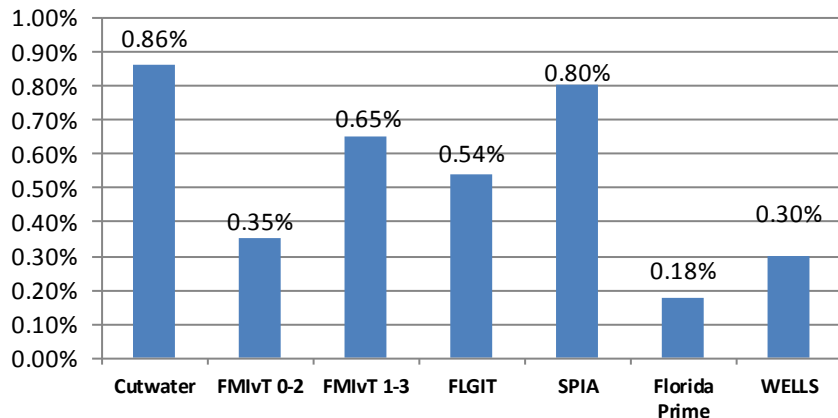

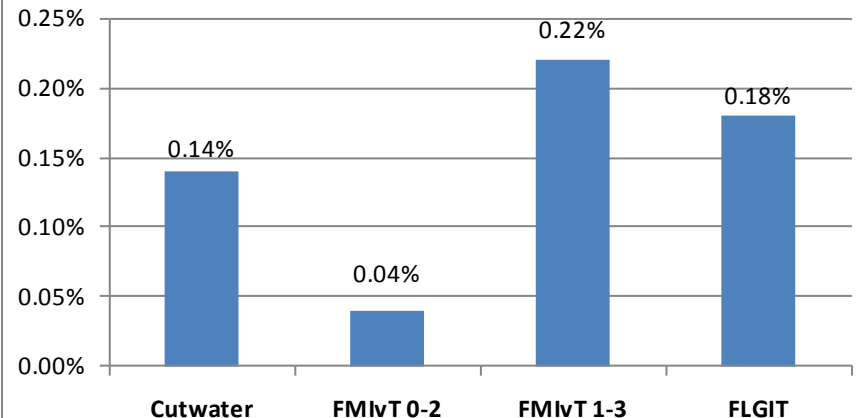

Yield as of December 31, 2013



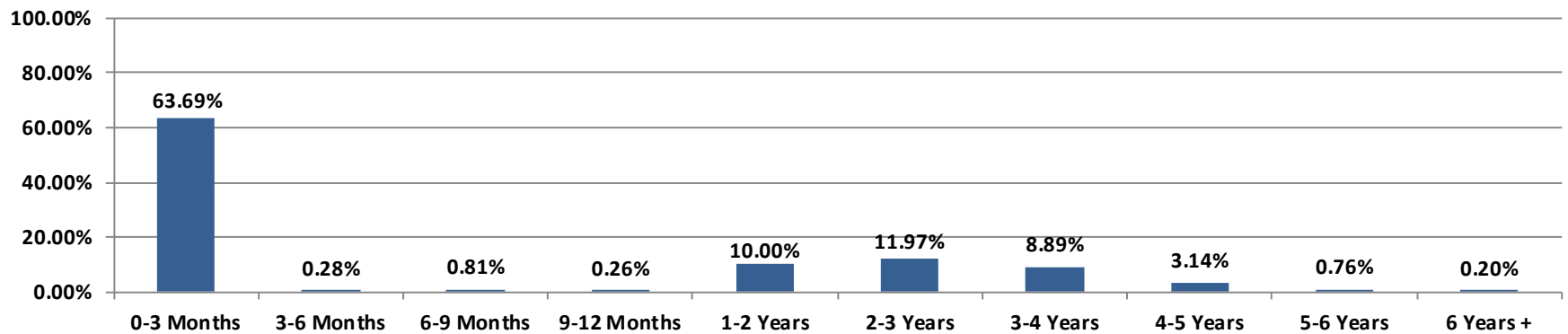
Quarterly Total Return

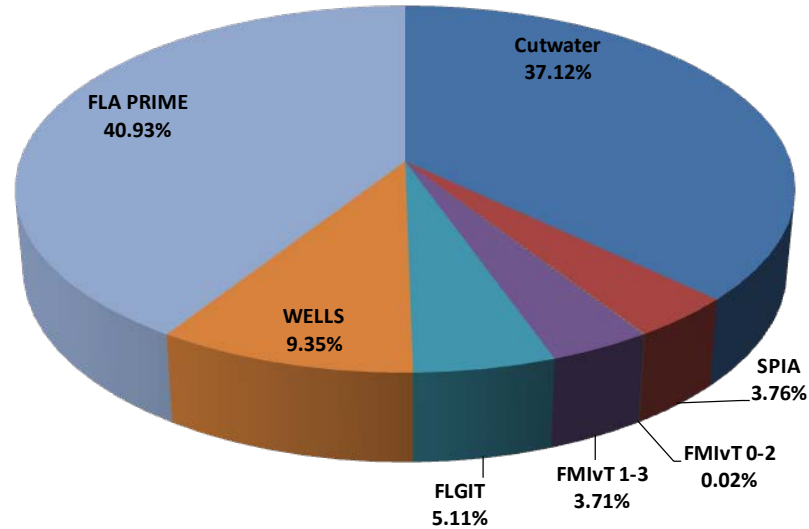

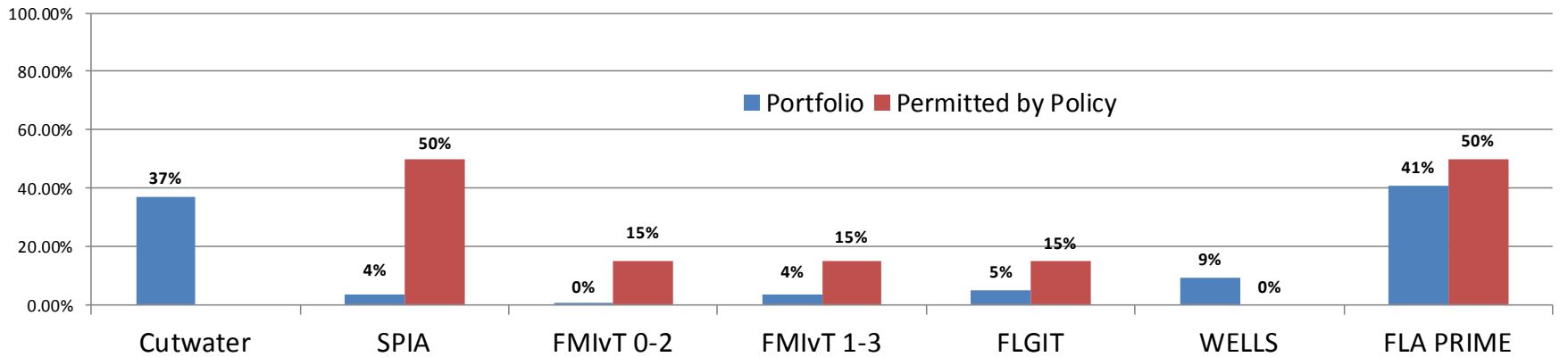

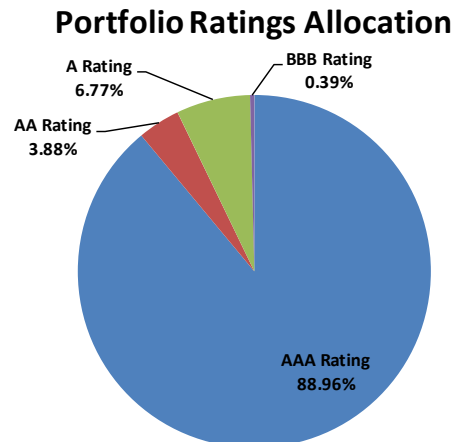

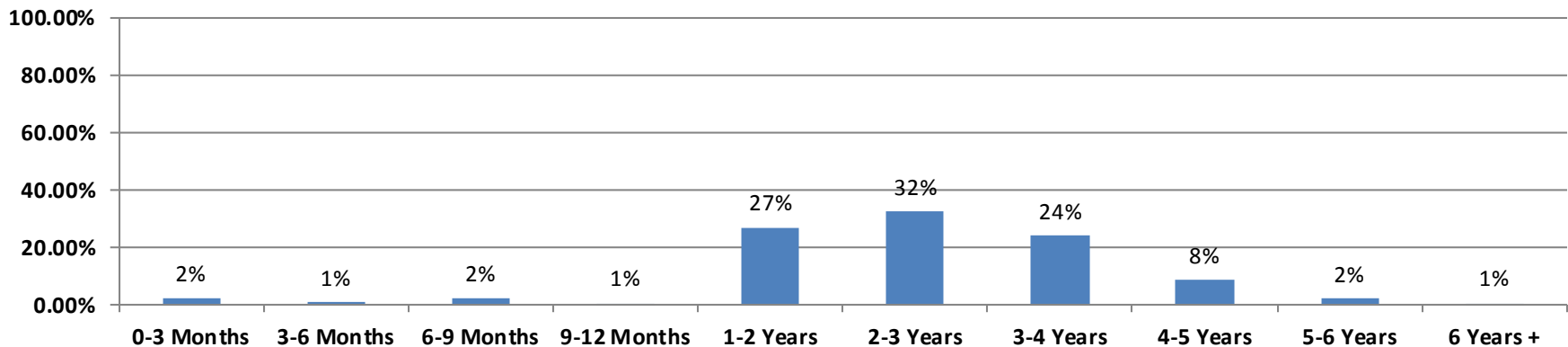

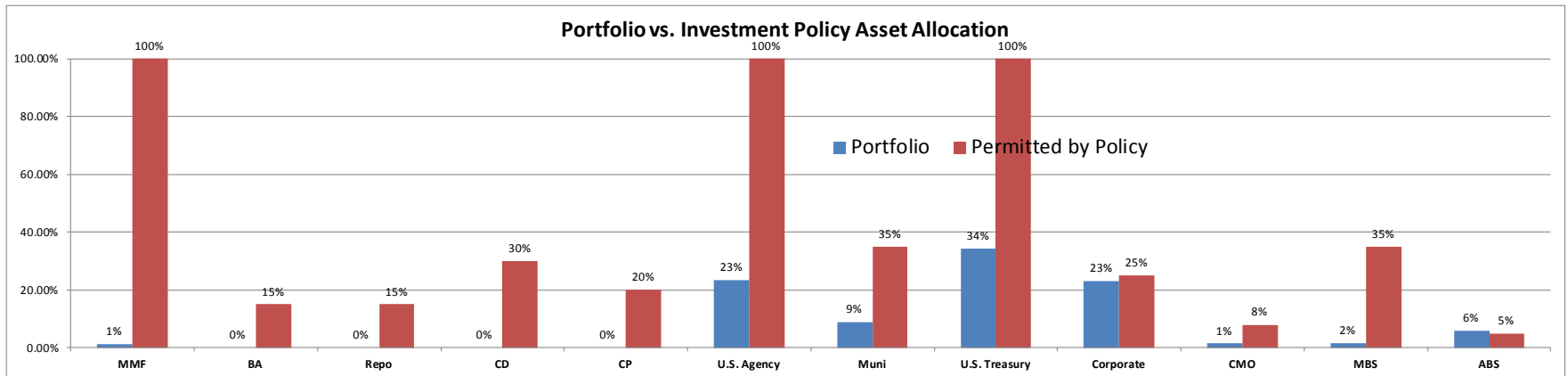
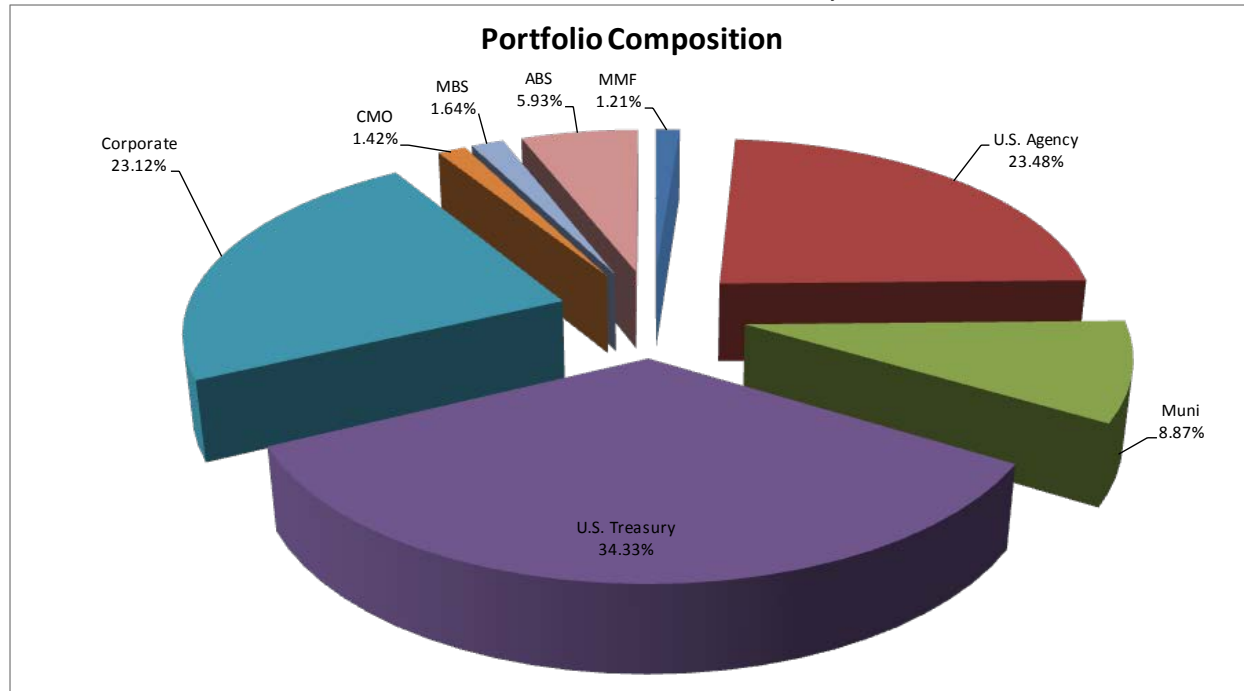
Portfolio Effective Maturity Distribution

Leon County Ratings Distribution for the Cutwater Managed Portfolio Quarter Ended December 31, 2013

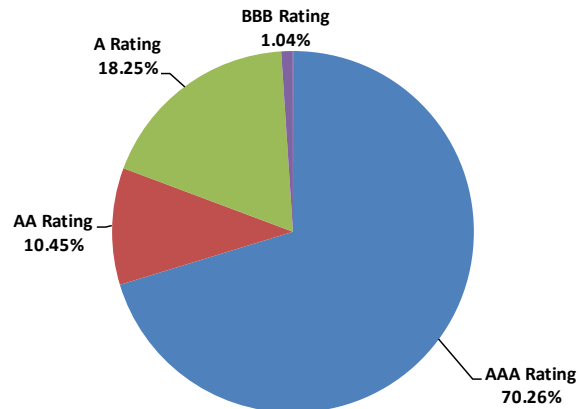
