SEVENTH AMENDMENT

IN RE: **CIRCUIT AND COUNTY COURT JUDGE ASSIGNMENTS,  
SECOND JUDICIAL CIRCUIT**

**WHEREAS**, Rule 2.215(b)(4), Florida Rules of Judicial Administration, provides that the Chief Judge shall assign judges to the courts and divisions and shall determine the length of each assignment, it is therefore

**ORDERED** that:

Sections I.E., I.F., and I.G. of Administrative Order No. 2007-04 are amended to read as follows:

**E. County Court Criminal Division**

County Judges Augustus D. Aikens, Jr., Ron Flury, Judith Hawkins and James O. Shelfer shall be assigned to the County Court Criminal Division which shall include all pending and previously scheduled hearing and trial dates and times associated therewith, as follows:

1. **County Judge Augustus D. Aikens, Jr.**  
Twenty five percent (25%) of all criminal cases.
2. **County Judge Ronald W. "Ron" Flury.**  
Twenty five percent (25%) of all criminal cases.
3. **County Judge Judith W. Hawkins.**  
Twenty five percent (25%) of all criminal cases.
4. **County Judge James O. Shelfer.**  
Twenty five percent (25%) of all criminal cases.

**F. First Appearances.**

All First Appearances, except otherwise assigned weekend holiday duty, may be assigned on a rotating basis as determined and assigned by the Administrative Judge for the Leon County Court.

**G. County Court Civil.**


County Judges Augustus D. Aikens, Jr., Ron Flury, Judith Hawkins and James O. Shelfer shall be assigned to the County Court Civil Division which shall include all pending and previously scheduled hearing and trial dates and times associated therewith, as follows:

1. **County Judge Augustus D. Aikens, Jr.**  
Twenty five percent (25%) of all civil cases.
2. **County Judge Ronald W. "Ron" Flury.**  
Twenty five percent (25%) of all civil cases.
3. **County Judge Judith W. Hawkins.**  
Twenty five percent (25%) of all civil cases.
4. **County Judge James O. Shelfer.**  
Twenty five percent (25%) of all civil cases.

**This Order shall become effective November 1, 2008.**

Except as herein expressly amended, Administrative Order 2007-04, as amended, shall remain in full force and effect.
